### 1. Chairperson's welcome.

The Chairperson welcomed everyone to the January meeting and wished all members a Happy New Year. Before proceeding with the agenda, Cllr Des Davies, the Vice Chairman expressed the Council's condolences with Cllr Williams and her family on the passing of her father recently. - 1a. Presentation by Mr Peter Williams on "Superfast Internet".** Mr Peter Williams attended the meeting and discussed the "Superfast Cyflymu Cymru" initiative. The Welsh Government and BT are in partnership to build on commercial roll-outs of fibre broadband in the country, with the Welsh Government's aim being that 96% of homes and businesses will have access to fibre broadband by 2016. Engineers have already begun building the new fibre network in a number of Welsh communities; the rollout to Cardigan is scheduled to commence in December 2014. The Chair thanked Mr Williams for a most informative presentation.
