## 10. Other Matters

**General Grass Cutting and Path trashing for 2013:** Quotation of £921.60 (including VAT) for grass cutting, £844.80 (including VAT) for path trashing, received from Mr John Morris. A quotation of £550 for path trashing was also received from Mr Tony Cole from Pontyclun. Councillors felt it was more practicable to employ a local person although the quote was higher. Accordingly, it was unanimously agreed that Mr John Morris be offered the contract.

**Water on the road outside Engar, Gwbart and mud on road near Heolgwyddil Farm, Ferwig:** The Clerk received a telephone call from the Chairman regarding the aforementioned matters. The Clerk contacted Ceredigion County Council requesting that they deal with the matters as soon as possible. **The work has been carried out but it is felt that the ditch which has been created in order to drain the storm water into the nearby culvert could be a danger to drivers and walkers due to its depth. The Clerk to notify the County Council of these observations.**

**The Cardi Bach:** The Clerk was asked to contact Mr Ian Dutch for the second occasion voicing the complaints received from members of the public regarding the vehicle used for the Cardi Bach service.
