Improvement to the entrance to Hen Ysgol y Ferwig

The clerk was asked to contact Jo Shaw regarding attending the May Council meeting to give a presentation.

**Ferwig Playarea:** The clerk to arrange a site meeting during March to discuss the timetable to complete the work following the inspection.

**Bin to be placed outside Ystafell Berkley:** After discussion with the Young Farmers Club it was suggested that the clerk contacts Mr Dyfed Symmons regarding placing the bin in concrete.

**Anti-Social Behaviour:** PC Alun Jones attended the meeting to make the Councillors aware of some anti-social behaviour involving young people at The Old School grounds in Ferwig over the last fortnight. Children and young people have been interfering with the property, vehicles and belongings of persons utilising the Old School. There is also great concern regarding fuel being emptied from boats at Patch.

**Pothole at Felinwynt Junction:** The clerk was asked to contact the County Council regarding this matter.

**Irresponsible Dog Owners:** Concern was raised that dogs are left to run freely in the field near Dolwerdd estate, Penyparc. The clerk was asked to contact the Environmental Department regarding placing notices prohibiting dog owners from letting their animals roam.

**Dogs fouling the pavements between Nantyferwig and the Boat Club:** The Clerk was asked to contact the Environmental Department for their advice regarding the placing of dog fouling control signs and for the owners to remove dog mess; also with the possibility of placing an appropriate bin in the vicinity.

**Lights outside Ysgol Feithrin, Penyparc:** The matter was raised that there is no light outside Ysgol Feithrin Penyparc. It was agreed that Cllr Auriol Williams pursues the matter.
