- 1. Chairperson's welcome.** The Chairperson, Cllr Llinos Price, welcomed everyone to the meeting. She also welcomed Mr Eifion Jones from Ceredigion County Council who came to explain the reclassification of road used as public path (**see item 10, no. 13**). Before proceeding with the agenda, she also welcomed Hannah Stevenson from Penyparc, who had the privilege of being chosen from 200 youngsters to visit Cambodia. Hannah thanked the Council for the financial gift she received and gave a very interesting talk on her visit, especially her time spent at a children's home. Cllr Llinos Price thanked and congratulated Hannah on her unique efforts.

- 5. Matters arising.**  
**Adventure Playground Wales Ltd:** Following a site meeting with Cllrs Llinos Price, Dilwyn Jenkins, Islwyn Iago, Des Davies, Morris Davies and the Clerk at Ferwig Playarea, the Clerk was asked to contact Mr David Stevenson regarding the work to be carried out at the playarea. The Clerk met with Mr Stevenson on Monday afternoon 19 March. Mr Stevenson promised to carry out the work on the swings by 2 April and that he would forward a quote for the remainder of the work to be carried out. **Mr Stevenson is still awaiting the delivery of the cradle swing so that the work can be completed and it was decided to postpone the remainder of the work due to the high cost.**  
**Rubbish bin outside Ystafell Berkley:** The Clerk to arrange a meeting with Penyparc YFC to discuss where the bin may be placed.  
**Signs prohibiting dogs without leads to roam:** The clerk contacted the Ceredigion Dog Warden regarding placing signs at Dolwerdd, Penyparc. He confirmed that this sign would be located as soon as possible. **The Council is still waiting for this to be completed.**  
**Dog Fouling on the pavement between Nantferwig and the Boat Club:** The Dog Warden was requested to locate a sign at Patch to help alleviate this problem and to place an appropriate bin.
