**Adventure Playground Wales:** The Clerk had requested a further update from Mr David Stevenson regarding the work required at the Ferwig play area. **As Mr Stevenson had not replied, it was agreed that the Clerk contact Mr John Morris enquiring whether he was interested in fulfilling the work which is now urgent.**

**Meeting with Penyparc YFC:** The Chairperson, Cllr Llinos Price, and the Clerk met with the officers of the Club. The cleaning arrangements are satisfactory to both Club and Council. ### **Balchder Pentrefi: Suggestions:**

Improve entrance to Hen Ysgol y Ferwig. **Miss Joanna Shaw attended the meeting to discuss various points regarding "Balchder Pentrefi". It was agreed to form a sub-Committee with Cllrs Llinos Price, Ann Stokoe and Auriol Williams and the Clerk in order to move on with this project.**

**Public path from Dolwerdd Estate to A487 highway:** Following complaints from members of the public regarding the state of the fence and gate 50 yards from the A487, it was decided to ask the Highways Department to investigate and report back to Council. It was also suggested that the County Council be requested to place new signs prohibiting dogs from running freely and for dog owners to clean up after their dogs.

**Benches at Gwbert Viewpoint:** The Clerk was asked to look into the ownership of the benches located at the viewpoint.

**Y Cardi Bach:** Cllr Llinos Price stated that the website GwerthwchiGymru.co.uk requests that bus companies submit quotes for this service. **It was suggested that the Clerk contacts the County Council once more voicing the Council's disappointment that this service is still not up and running despite the fact that we are now well into the tourist season.**

**Highcliff Gwbert:** Cllr Dilwyn Jenkins stated that the new drive constructed at Highcliff exceeds the property perimeter and has the potential to cause danger to vehicles using the highway. The Clerk was asked to write to Highways Department.

**Benches on path past the Cliff Hotel:** Cllr Dilwyn Jenkins stated that he had received information that work needed to be carried out on these two benches. A coat of paint is needed on one and the other is in need of repair and painting. The Clerk has contacted Mr Dyfed Symmons asking him to carry out this work as soon as possible.
