She also congratulated Cllr Auriol Williams on becoming a grandmother once again. The Council proceeded to discuss the agenda.

Path 73/3 Garnhegoydd to the Golf Club: The clerk received a telephone call from Mrs Wendy Campion (17/5) regarding the overgrowth on the path. She stated that she was awaiting permission from the Countryside Council for Wales before moving on with clearing the path. **Cllr Dilwyn Jenkins stated that the path had since been cleared.**

PACT Meeting 10 May, Gogerddan Arms: The clerk attended the meeting. They confirmed that they were monitoring the suggestions presented to them by the Young Farmers' Club previously (the use of mobile phones when driving and speed cameras.)

A comprehensive discussion took place regarding the appropriate points appertaining to Ferwig Community Council.

- a) Land at Heol Las Fawr (new land earmarked for housing): Cllr Dilwyn Jenkins declared an interest. It was decided not to forward observations at this time.

- b) Land at Penparc Farm (a new site put forward for employment): Cllr Llinos Price declared an interest. As the plans were unclear, It was decided not to forward observations at this time.
Proposed by Cllr Islwyn Iago and seconded by Cllr Auriol Williams.
- c) Parc y Capel (a new site put forward for housing): Cllr Llinos Price declared an interest. It was decided not to forward observations at this time.
Proposed by Cllr Morris Davies and seconded by Cllr Huw Jones.
- d) Cardigan Sand & Gravel, Penparc: Cllr Auriol Williams left the meeting. The Council offered observations as follows:
"Ferwig Community Council reiterates all the previous points noted in the letter dated 8 February 2011 (a copy of which is attached) and also wish to add the following comments:
Our understanding of pages 80 and 96 is that both pages deal with the same issue, i.e. the recommendation that the small section highlighted be retained for quarrying.
Ferwig Community Council dissent from this viewpoint and object, as that small section is a very valuable asset in that it will prevent wind-blown sand from becoming a polluting agent for nearby properties. It will also assist in preventing wind-blown sand reaching other properties in the village of Penparc during stormy weather conditions."

11. Other Matters

Standard of hygiene at Ystafell Berkley Changing Rooms: Complaints have been received from the public regarding the hygiene and cleanliness of the changing rooms. The Clerk was asked to write to Mrs Karen Jones, the caretaker, to discuss the job contract.

Clerk's Vacation (January/February 2012): An application was received from the Clerk for leave of absence from 20 January 2012 for five weeks for her journey to New Zealand.

Permission was granted: proposed by Cllr Lyn Jones and seconded by Cllr Dilwyn Jenkins.

Grasscutting in Penparc: Mr John Morris requested information regarding the grasscutting at the Brongwyn crossroads. It is the County Council's responsibility to maintain the section below Heol y Felin. Following the work carried out on the opposite side of the crossroads, the guttering has not been completed and grass seeds need to be scattered. **The Clerk to inform the County Council.**
