- 1. Chairperson's welcome.** The Chairperson, Cllr Llinos Price, welcomed everyone to the meeting. The Council proceeded to discuss the agenda.

With the above corrections it was proposed by Cllr Lyn Jones and seconded by Cllr Ann Stokoe that the minutes for June were correct.

- 5. Matters arising.**
  - Mrs Karen Jones (Caretaker):** Following receipt of a letter from the clerk, a telephone call announcing her resignation from the position was received from Mrs Jones. The clerk asked her to confirm her decision in writing (**see item 10, no. 106**). The issue was discussed with the Chairperson and it was decided to advertise the position on the council noticeboards. **The matter was discussed further and three enquiries have been received. It was decided to ask for written applications to be submitted to the Council.**
  - Penyparc Football Club goalposts:** The clerk received a telephone call from Mr Morlais Davies confirming that the goalposts had been removed from the field. Correspondence was also received for financial aid to assist in purchasing new goalposts for the club (**see item 10, no. 107**). **The request was discussed and it was proposed by Cllr Morris Davies and seconded by Cllr Islwyn Iago that the Council donates £272 towards the cost of buying new goal posts for the club.**
  - Bus Shelters:** Response received from the County Council that the shelters were the responsibility of the Community Council (**see item 10, no. 97**). **The clerk was asked to contact Mr John Morris for a quotation for cleaning the shelters.**
  - Work to be completed on the highway (see item 10, no. 98).**
  - Pathway from Patch to Gwbert:** Information from the County Council that the work had been done (**see item 10, no. 99**).
  - LDP Ceredigion 2007/22:** It was decided to act upon the observations as shown in the June minutes. **Following a short discussion it was decided to submit the relevant form together with a covering letter containing the observations to the County Council by 12 July.**
