- Chairperson's welcome.** In the absence of the Chairperson, the Vice-Chairman, Cllr Dilwyn Jenkins, welcomed everyone to the meeting. The Council proceeded to discuss the agenda.

With the above corrections it was proposed by Cllr Islwyn Iago and seconded by Cllr Lyn Jones that the minutes for July were correct.

**Ceredigion Local Development Plan:** Additional and Corrected Site Allocation Representations Consultation (July 2011). Information e-mailed to councillors on 24 July (**item 10[113]**). **One site only was discussed: Graig, Mwnt, have placed a new application for tourism. The clerk was asked to respond with observations as follows: that the development of this magnitude would be too large for this rural environment. It would be unsuitable for the landscape and an increase in vehicles along narrow country lanes would cause traffic management problems.**

**Application for a litter bin on the football field:** Acknowledgment from the County Council that they had received the application.

**Proposed Meeting of the Teifi Estuary Advisory Board (TEEMI):** Information and agenda re. meeting. Agenda handed to Cllr Ann Stokoe (**item 10[115]**).

**Sponsored Walk by pupils of Ysgol Uwchradd Aberteifi:** Response to the letter of complaint re. the behaviour of a number of pupils on the walk (**item 10[116]**).

**Cleaning of Bus Shelters:** A quotation of £120 (including VAT) received from Mr John Morris for cleaning the shelters (**item 10[117]**). Following a discussion with the Chairperson, Cllr Llinos Price, the clerk contacted Mr Elwyn Rees, Abacus Cleaning Services, who quoted a price of £24.75 per shelter. Mr Rees was asked to proceed with the work.

**Ceredigion County Council:** Confirmation that the inspection of the Ferwig play area will take place in September (**item 10[123]**).

**Application for the postion of Caretaker/Cleaner:** A written application was received from Penyparc YFC (**item 10[125]**). Following a short discussion, the contract was offered to Penyparc Young Farmers' Club to commence from 5 September. (Prejudicial interest was expressed by Cllr Lyn Jones.)

**Footpath from Tremain to Blaenannerch:** An update was received from Mid-Wales Trunk Road Agency (**item 10[134]**).

**Infants Swing at the Ferwig Play Area:** The clerk asked Mr David Stevenson, Adventure Playground Wales, to e-mail a quotation for the replacement of the swing to an infants swing.

**Naming the Estate at Cwmarch:** The clerk has spoken to the building contractor regarding the name. He stated that "Brynwel" would be the temporary name, with the suggestion of naming it "Brynwelon". Once the work on the estate is completed, it is expected that the County Council will have the site adopted.

**Viewpoint near Waunghelod:** As a result of complaints received from members of the public regarding the condition of this litter-strewn viewpoint, the clerk e-mailed Countryside Council Wales. Cllr Huw Jones disclosed that Mr Nick Laing, Allt yr Afon, is the rightful owner of the viewpoint. The clerk was asked to forward a letter to Mr Laing requesting him to close down the viewpoint completely.

**Path 788 Aberdare Farm to Felinbedr:** It was brought to the attention of the Council that a large tree trunk was obstructing the footpath. The clerk has written to the County Council.

**The Porch Floor at Ystafell Berkley:** The Chairperson, Cllr Llinos Price, asked the clerk to contact Mr Malcolm Maskell to make safe the floor with a new piece of linoleum. **The work has since been completed.**

**Litter strewn at Penygarn:** Cllr Islwyn Iago informed the clerk of the offending litter at Penygarn. The clerk duly informed the County Council (**see item 10, no. 135**).
