1. **Chairperson's welcome.** The Chairman, Cllr Dilwyn Jenkins, welcomed everyone to the meeting. He congratulated all local pupils who were successful in their GCSE and 'A' Level examinations and extended good wishes to those who are leaving to attend further education

2. **Apologies for absence:** There were no apologies.

3. **Minutes of the previous meeting.**

It was proposed by Cllr Llinos Price and seconded by Cllr Des Davies that the minutes of the July meeting were correct.

4. **Declaration of personal interests:** None.

5. **Matters arising:**

Benches at the Gwbert Viewpoint: The Clerk is continuing her research into ownership of the benches. As the general condition of the benches was deemed satisfactory, it was agreed to defer decision for the time being. If their condition deteriorates, the Council will raise the matter at a future date.

Highcliff, Gwbert: Following numerous complaints received regarding the protrusion of the driveway, the Clerk was asked to obtain further information from the County Council regarding this. It was confirmed that the appropriate officers would investigate. Cllr Haydn Lewis (local member of the County Council) has written to the County Council regarding this. A copy of this letter has been forwarded to the Clerk. The Clerk has received a copy of the letter sent by the County Council to the owner of Highcliff stating that he has one month to correct the driveway; upon failure to adhere to this request, the County Council would complete the work and invoice the owner. As the work had not been completed by the beginning of August, the Clerk was asked to contact the County Council once more. The work has now been commenced; it was, therefore, suggested to ask the authority to inspect the present position.

Incomers to Ceredigion: Cllr Haydn Lewis has written to the County Council asking for information regarding the financing of incomers to the county. Ceredigion County Council was asked to forward a copy of the reply to the Clerk.

Cllr Lewis stated that he would pursue the matter by the October meeting.

Junction between Llwynllwyd Fach/Lleine Price: The County Council replied stating they would contact the Council again regarding this work when local work concerning traffic and highways would be considered.

Path from the Gwbert Viewpoint to the Cliff Hotel: The Clerk had received a telephone call from Mrs Wendy Campion (2 August) stating that the work would be completed in the near future. **Work has now been completed.**

County Council Planning Department: Response regarding the request of the Council for directives concerning a variety of planning applications (see item 9 no. 69). **It was agreed to discuss the possibility of representation from the Council to attend a meeting at Penmorfa with officers of the department. It was further agreed to discuss the timetable in the October meeting.**

Village Renewal Fund: Suggestions:

Information Board to be located in the community.

Improvement to the entrance to Ferwig Old School.

The sub-committee has moved the project on. The Clerk was asked to contact One Voice Wales regarding directives on receiving a donation from "Hen Ysgol y Ferwig" towards widening the entrance at the school. Cllr Auriol Williams stated that the sub-committee was in the process of forwarding a letter to Mr Neale Hinchcliffe underlining the proposals of the sub-committee in order to place an application with Balchder Pentrefi. He was also informed that an application would be forwarded to the County Council for permission to proceed, and to request a site meeting as soon as possible. Members of the sub-committee met with Mr Hinchcliffe. It was concluded that permission of the owners of the old school, Ceredigion County Council, would have to be sought before moving to widen the entrance. It was agreed that the Clerk contact Jo Shaw, Project Officer Balchder Pentrefi, asking for suitable dates to organise a meeting.

Rubbish left on the beach at Patch: The Clerk received a telephone call from a member of the public regarding bags of dog mess etc being dumped on the beach at Patch. The Chairman confirmed that he had visited the area and the Clerk was asked to contact the Dog Warden. He also visited the location and promised to contact the Clerk when he had more information. Cllr Haydn Lewis, Local County Council member, wrote to Afon Teifi Fairways (the Clerk has a copy of this letter). The Clerk again contacted the Dog Warden on 3 July. He stated that he was still awaiting information from the County Council and would contact the Clerk when any information came to hand. As Afon Teifi Fairways Ltd is the body responsible for the lease, it was resolved to write to them asking them to locate a bin alongside the skip and to post a notice informing people that it was solely for the use of fishermen.

Footpath from Gwbert Viewpoint to the Cliff Hotel: Following complaints received regarding overgrowth on the path, it was suggested that the Clerk contacts the County Council asking them to cut the grass on either side of the path. **The work has been completed.**

Bridlepath between Llain y Cwm and Trecefn Isaf: Cllr Auriol Williams received complaints that this bridlepath was overgrown. The Clerk was asked to contact Mr John Morris who promised to deal with this immediately. **The work has been completed.**

Morgan's Beach, Gwbert: The Clerk received a telephone call from Mrs Shirley Daniel asking for handrails to be placed alongside the path to Morgan's beach. It was agreed to forward a letter to the County Council reminding them of their statement in 2003 to widen and level the steps to the beach to assist walkers. It was stated by the authority in that letter that it was impossible to place handrails due to the flaky condition of the rock. The Clerk was asked to inform Mrs Daniel of these facts.

"Y Cardi Bach": Cllr Dilwyn Jenkins aired his concerns that the vehicle was not as obvious to walkers with its insipid colouring and that the wording on its body was not large enough. The Clerk was asked to obtain the latest statistics regarding the use of the service from the County Council.

Mrs Amanda Rogers: The Clerk was requested to forward a letter of support to Mrs Rogers in her plight to obtain the required medication to treat her serious medical condition. **The clerk confirmed that a letter had been sent.**

Penyparc Football Field: An application has been received from Penyparc FC for the pitch to be rolled before undertaking a risk assessment. Following a site meeting between the Chairman, the Clerk and members of the Club, it was resolved to ask Mr Gareth Owen to complete the work. Mr Owen was concerned that the molehills would have to be removed before rolling would be beneficial. He was asked to proceed with the grasscutting.

Overgrowth on the pathway between Aberdare Farm and Felin Bedr: Although this work had been carried out earlier, complaints had been received that sections of the pathway were again impassable. The Clerk has contacted Mr John Morris to cut the overgrowth.

Mud on the road, etc.: Cllr Islwyn Iago stated that there was mud on the road in the passing bay between Blaenwaun and Graig. He added that the "Temporary road surface" sign was still abandoned on the roadside. The Clerk has contacted the County Council.
