A quotation of £40 for the work and for special glue has been received from Mr John Morris. The work has now been completed.
- (b) **The hedge leading from the Boat Club to the Viewpoint:** The hedge is badly overgrown with thorn. The Clerk has spoken to Mr Nigel Nicholas who has promised to organise the cutting of the hedge.
- (c) **(i) General grass cutting 2015; (ii) Grass cutting at the Football Field, Penyparc:** It was agreed that (i) Mr John Morris would continue with this work, and (ii) Mr Gareth Owen would continue to cut the grass on the football field. It was agreed to obtain quotations at three year intervals.
- (d) **Oil drum:** An oil drum has been left on the side of the road between Llys Newydd and Arafon, Tremain. The Clerk was asked to contact the North & Mid Wales Trunk Road Agency to remove the container.
- (e) **Pavement from Tremain to Penyparc:** The Clerk was asked to request the North & Mid Wales Trunk Road Agency to place signs informing that the pathway is suitable for cyclists and pedestrians.
- (f) **Public Path and Bridle Way between Heol Gwyddil Fach and Y Bryn Farm:** The Clerk was asked to request that the County Council repairs the second gate on the path; the wood has perished making it difficult to open from horseback.
- (g) **Cycle path between Banc y Warren and Penyparc:** A light barrier placed on the path is in danger of obstructing the highway following gusts of heavy wind. The Clerk was asked to inform the North & Mid Wales Trunk Road Agency informing them of this potential hazard.
- (h) **Gwbert Viewpoint:** Cllr Dilwyn Jenkins suggested that the wording on the boulder at the entrance needs repainting. The Clerk to ask Mr John Morris for his opinion.
- (i) **The proposed new section on the M4 corridor near Newport:** The Clerk was asked to forward a letter of protest to Elin Jones AM complaining that the astronomical cost of the work is unacceptable.
