- (j) **Pwll y Bwmper:** The Clerk was requested to contact the County Council for an update regarding the ruins located alongside the A487 at Penyparc.
- (k) **Light near Blaencathra, Penyparc:** As the tree within the property impedes on the light source, it was agreed to ask the County Council to instruct the Community Council as to the action required.
- (l) **Rubbish left in field at Penyparc:** A complaint has been received from members of the public regarding disused furniture left in the field adjacent to Heol Tywod, Penyparc. The owner confirmed that the furniture would not be set alight.
