### 1. Chairperson's welcome.

The Chairperson, Cllr Auriol Williams, welcomed everyone to the April meeting, and went on to discuss the agenda.

### 3. Minutes of the previous meeting.

### 5. Matters arising:

- (a) **Council Website:** The Clerk is presently in the process of forwarding files to Telemat. The minutes for the last three years have been forwarded in pdf format.
- (b) **Path leading to the beach at Gwbert:** This work has now been completed.
- (c) **Official Opening of Cae Gwyrdd, Penyparc:** Arrangements are completed and all Councillors were invited to attend the event. The Chairperson stated that she would be bringing squash and biscuits for the children.
- (d) **Traeth yr Ogof Goch:** Following a meeting between Mr Nigel Nicholas and Cllr Dilwyn Jenkins, it was stated that the path was not in such a poor condition as originally reported. The Clerk was asked to contact Mr Nicholas enquiring as to the inclusion of the steps as a section of the coastal path.
- (e) **Stile at Penyparc Chapel Cemetery:** The Clerk was advised by Cllr Haydn Lewis that the repair work on the stile had been carried out.
- (f) **Blocked gutters near Treprior and Ffynnonbedr Chapel and also by the junction between Siloam Chapel and Heolcwn Farm:** Cllr Haydn Lewis is organising a site meeting with Mr Gary Griffiths from the County Council (see Item 5(h)).
- (g) **"Private – No right of way" sign between Felin and Blaenpistyll, Tremain:** Email received from Mr Eifion Jones, Ceredigion County Council, confirming that there is no public path of any description at this point; the owner has every right to place "Private" signs thereat (see Item 9[160]).
- (h) **Rusted gate on footpath 73/29 (Dolwerdd, Penyparc):** Confirmation received from Mr Nigel Nicholas that the gate and fence have been repaired. The Council had offered to place a new gate at this point in 2012; the offer was refused by the owner. As ownership of the gate had since been transferred, the Clerk was asked to contact Mr Nicholas to review the situation.
