- 1. Chairperson's welcome.** The Chairperson, Cllr Lyn Jones, welcomed everyone to the June meeting. He congratulated the Clerk on becoming a grandmother to a new born grandson, Ianto, in New Zealand.

1(a) Presentation "Awel Deg Aberteifi": A proposal to place a wind turbine on the land of Oernant Farm.

The Chairman welcomed representatives of Awel Deg Aberteifi to the meeting and invited Ms Sarah Wright to commence the presentation. She gave a comprehensive background to the venture and stated that one of the aims was to help the surrounding district become as self-reliant in energy as possible by creating community-owned renewable energy projects. Mr Peter Newland continued the presentation and stated that the plan for the Oernant Farm wind turbine would be for a 500Kw turbine with a height to hub of 45m, 67m to blade tip. A planning application will be submitted to Ceredigion County Council in the summer. It was stated that the area is blessed with huge potential for renewable energy generation with the income from the project able to unlock some of the potential and provide a community gain for local community projects including the local swimming pool at Cardigan which has experienced considerable cuts in its funding from the county council. Informative diagrams and photographs were distributed for members' information.

An information stall will be displayed outside the Guildhall, Cardigan, on Saturdays, 6 and 13 June, from 10.00am-12.00 noon with a meeting scheduled to be held at the Small World Theatre on 10 June.

Following a question and answer session, the Chairman thanked the Awel Deg Aberteifi representatives for their most useful presentation.

[25] **The observations of Ferwig Community Council regarding the idea of shared ownership of homes.** Councillors are of the sound belief that allowing tenants to buy a share of their property is a good idea. They also feel that the outcome of providing more homes is worth pursuing and believe that local people should have priority. Members added that the scheme should be adopted across Wales by other housing associations. Finally, it was agreed that no type of property should be excluded from the scheme.

10. Other Matters:

- (a) **The "Corner" road sign near the Flat Rock car park in Gwbert:** The sign post was slanting at approximately an angle of 45 degrees after a vehicle collision. The information has been forwarded to the County Council highways department; the problem has now been rectified.
- (b) **Nomination of a member to represent the Council on the Ysgol Gynradd Penyparc board of governors:** Cllr Eurig Lloyd has been nominated to serve on the board.
- (c) **Cycle Path from the entrance of Cardigan Sand & Gravel to Caemorgan Road:** The Clerk was asked to request an update from the County Council highways department regarding the proposed completion of the cycle path.
- (d) **Overhanging branches at the entrance to Sandy Way, Penyparc, from the A487 highway:** Complaints have been received from motorists that the overhanging branches are impeding the visibility for motorists leaving the estate onto the highway.
