However, horses fouling on pavements is NOT an offence and the owners are NOT obliged to clean up after the horses. Fouling legislation only applies to dogs, specifically due to illnesses that can be passed on via the faeces."

During the course of my patrols I have not seen any horses riding on the pavement in and around Penyparc leading to Tremain. However, horses fouling on pavements is NOT an offence and the owners are NOT obliged to clean up after the horses. Fouling legislation only applies to dogs, specifically due to illnesses that can be passed on via the faeces."
 - (b) **Hedge overgrowth on the Feidr Tywod junction with the A487 main road:** The hedge, which has caused potential hazard to motorists, has now been cut.
