10. Other Matters:

- (a) **Commemorative slate opposite the Old School in Ferwig:** The slate has since been removed by the Community Council for health and safety reasons. A quotation of £375 + VAT has been received from Mr Dyfed Symmons for its re-positioning on the Old School wall. It was agreed that Cllr Lyn Jones discusses the relevant work with Mr Symmons.
The following was noted: Cllr Des Davies displayed the original spade with the plaque which depicted the wording: "Presented to D. Jenkins, D.C. to commemorate the cutting of the first sod of the Verwig Water Scheme, June 22, 1936. Teifi Side Rural District Council."
- (b) **The lane surface between Bolafron and Penfeidr, Ferwig.** It was agreed to consult the highways department regarding the severe state of the lane and the hazardous potholes.
- (c) **Chairman's Dinner:** Two dates were suggested: April 24 and May 1. The Interim Clerk was requested to contact the Golf Club steward for availability.
- (d) **Footpath Signs from the Dolwerdd estate to the A487 main road:** Mr Nigel Nicholas has confirmed that the signs will be in situ by the end of this financial year.
- (e) **The pathway from Oernant Farm alongside the Brambles and Muriau Gwyn dwellings in Feidr Tywod, Penyparc:** Following complaints received of mud and soil spillage from agricultural vehicles traversing the Oernant Farm lane, it was agreed to inform the highways department for action.
- (f) **Parking of vehicles on the pavement at Heol y Felin, Penyparc:** Cllr Llinos Price agreed to contact PCSO Matthew Kieboom regarding this problem which impedes the path for children, the elderly and pushchair users.
- (g) **Dog Mess:** Cllr Llinos Price was concerned at the behaviour of irresponsible dog owners allowing their animals to foul the pavement and road from Heol y Felin to Ystafell Berkley. It was agreed to contact the County Council Dog Warden.
- (h) **The Crib-y-gwynt, Ferwig Development:** Cllr. Islwyn Iago has concerns regarding the condition of the verge bordering the property alongside Crib-y-gwynt as it is not of the expected criteria. It was agreed to contact the planning authorities for further information.
