- (a) **Code of Conduct for Members (Ceredigion County Council).** Adopted by the County Council on 21 April 2016 an effective from 20 May 2016. Ferwig Community Council has to adopt the document as advised by the external auditor.

- (b) **Translating sections of the website:** Following the Welsh language scheme policy, sections of the website require translating. The Clerk will organise that this task is done in due course.
- (c) **Brynteg, Ferwig:** The Clerk was asked to contact the County Council technical services once more regarding an update to this unauthorised development. The plinth holding the slate was located where the entrance has been created, therefore making it impossible to resite the slate.
- (d) **Bus Shelter on the A487 (opposite the O. C. Davies & Son garage):** The bus shelter is in need of cleaning. Cllr Peter Williams stated that he would enquire as to who is responsible for its cleaning.
- (e) **Dog Fouling at Penyparc:** Cllr Llinos Price stated that she would speak to the headmistress at Ysgol Gynradd Penyparc suggesting that a competition be arranged for pupils to create a poster. Matthew Kieboom PCSO has also stated that he would be willing to give the pupils a talk highlighting this problem.
- (f) **Christmas Lunch for the over 70's in the community:** The Chairperson, Cllr Llinos Price, and the Clerk will arrange a date with Cardigan Golf Club.
- (g) **12 Heol y Felin, Penyparc:** Issues regarding the flat have been reported to Tai Ceredigion by the Chairperson; an officer has been allocated to investigate the concerns.

## 11. County Councillor's Report – Cllr Clive Davies:

- (a) **Parking at Patch:** Ceredigion County Council has been successful in obtaining a grant for creating a plan of action for ports in Ceredigion under the "Way Forward" strategy from the Welsh Government. This scheme includes development in the Teifi estuary, so there will be a consultation with the Afon Teifi Fairways Committee and the local councils within the next four months.
- (b) **Monitoring of vehicle speed through the village of Penyparc.** Cllr Davies reported that the developing of the speed watch both in Penyparc and Llechryd is progressing. The Penyparc site has been identified, and residents have volunteered. Police checks and personnel training will be organised during the coming months.
- (c) **Mwnt Road:** It has been reported that the traffic level on the road to Mwnt during the majority of the year is causing concern. There is a necessity to look at options for passing bays and improving sections of the road. Cllr Davies is awaiting a response from the Highways Department.
- (d) **Blaenpistyll road, Tremain:** Issues with water and lack of drainage on this section of the highway have been reported to Cllr Davies who has attended the location and forwarded photographs to the County Council for a plan of action. A response is awaited.
