- 1. Chairperson's welcome:** The Chairperson, Cllr Auriol Williams, welcomed everyone to the September meeting after the Summer recess. She wished Cllr Matthew Morgan well on his new venture on Pentood Industrial Estate.
- 2. Apologies for absence:** Cllrs Des Davies and Eurig Lloyd, and Carys Owens, Porth y Gymuned.
- 3. Minutes of the previous meeting**  
It was proposed by Cllr Matthew Morgan and seconded by Cllr Lloyd Jenkins that the minutes of the July meeting be recorded as correct.
- 4. Declaration of personal interests:** Cllrs. Llinos Price, Cllr. Clive Davies regarding Ysgol Gymunedol Penparc
- 5. Matters arising:**
  - (a) Council's Boxes of Paperwork:** The boxes in the hands of Mrs. Hildreth Owen were discussed. It was agreed that it's important to keep all minutes. Clerk will ask how long minutes and papers need to be kept. It was also agreed to have a look at the contents by bringing one box to the next meeting prior to looking at the remainder.
  - (b) ROSPA:** Cae Gwyrdd, Penyparc. Mr John Morris has undertaken improvements to the condition of the playing field. We need to see whether the Community Chest has grants available for a new surface in some areas of the playing field. Cllr Peter Williams will inspect the surface and the Clerk will make enquiries to the Community Chest.
  - (c) Councillor vacancy:** A letter that had been received from Mrs Delyth Phillips was discussed for the vacancy. Cllr. Llinos Price proposed that she be co-opted, this was seconded by Cllr. Dilwyn Jenkins.
  - (d) Ysgol Gymunedol Penparc:** Substantial work needs to be done to the school in terms of structure, central heating, painting and creating a quiet area (please see requests for financial support below). A letter shall be sent to the County Council expressing concern about central heating, and therefore the health and welfare of pupils and staff.

## 10. Other Matters:

- (a) **Gwbert Benches:** The three benches on the other side of the Cliff Hotel which were placed there in 2000 need varnishing, as well as 3 at the viewpoint. Clerk to organize this.
- (b) **Sat Nav Issues:** Following problems with vehicles getting to the Cliff Hotel, the Clerk was asked to contact the Technical Services at the Council in relation to the possibility of erecting a sign. A letter with examples of issues needs to be sent.
- (c) **Bryn Teg:** A plan of the proposed work was seen. Clerk to ask again for a quotation.
- (d) **Defibrillator:** Please refer to Cllr. Clive Davies' report below – 11(h).
- (e) **Naming of roads:** Steffan Jones has responded noting that there are several things to consider before being able to name roads, such as consulting people living on those roads, the issue of changing postcodes and the costs involved with erecting new signs. It was decided to leave the matter for the time being.
- (f) **Gwbert Viewpoint:** Potholes have been filled following complaints.
- (g) **Bench in Penyparc village:** It was agreed that a letter should be sent thanking the local residents who have been planting flowers in pots next to the bench on the crossroads.

## 11. County Councillor's Report – Cllr Clive Davies:

- (a) **Penyparc Carnival:** He recently attended the carnival where he enjoyed judging the numerous competitions.
- (b) **Blaenpistyll:** He informed that the road would be closing for work by BT. No complaints had been received.
- (c) **Hedge cutting:** Several complaints were received regarding bad hedge cutting.
- (d) **Welsh Water:** He had been informed that the reservoir in Penyparc had a leak. Welsh Water intend to fix the problem but it will interrupt Penyparc's supply for a period of time.
- (e) **Hen Ysgol y Ferwig:** Planning Application. Awaiting a reply from Arwyn from the Council regarding his email on the site's purchase. He stated that Catrin Newbold from the Planning Department was hoping to have the money from the Government in September.
- (f) **Parking at Patch:** People have started parking on the hill. The police are adding patrol officers who have received tidal timetables. He said that the Community Council and the Boating Club need to co-operate on this. It is hoped that the council will meet with the boating club regarding parking and the development of the Patch area.

- (g) **Mwnt Lifeguards:** The councillor informed that he had spoken to Lee Fisher. The County Council pays for a lifeguard to be present on 6 beaches. It's possible that there will be no lifeguard on Mwnt at times. The National Trust's policy states that if the rip is bad, they could close the beach. Lee will work with Paul Boland from the Trust on the policy over winter to find a way forward to resolve this.
- (h) **Mwnt Defibrillator:** The National Trust is willing to contribute towards this. A local resident has been asking for contributions. The money will be in place and the Council will possibly need to contribute towards it. Cllr Clive Davies will ask how much the Trust is willing to give. Clerk will speak to the local resident asking how much has been raised.
- (i) **Digital Champion:** Cllr. Clive Davies informed the Council that he has received the new title of the County Council's Digital Champion and is now also Chairperson of Licensing. He was congratulated by Cllr. Auriol Williams.
- (j) **Speedwatch:** Members were informed that things are moving forward in Penyparc.
- (k) **Local Development Plan:** Closing date for the 2019-2033 LDP is 12 September. Cllr Clive Davies drew attention to this and to the Council's map for the area. Future suggestions can be proposed by zooming in to the areas and providing comments on the website.
- (l) **Place Plans:** A meeting will be held on 9 September with the other 6 places.
