- Achubwyr Bywyd Mwnt** – roedd wedi cyfarfod â'r RNLI a thrafod gyda'r awdurdod lleol a'r Ymddiriedolaeth Genedlaethol. 10. Other Matters:

- (a) **Boxes in the hands of the previous Clerk:** Arrangements need to be made regarding the contents of the boxes in the hands of the previous Clerk. It was agreed that a short meeting would be held in February where everyone would spend an hour prior to/after the meeting to go through the contents.
- (b) **Sat Nav to Waunelod –** The County Council's response was discussed. It was decided to discuss this matter in the next meeting and Cllr. Lyn Jones would take a look at the signs currently in place prior to the meeting.
- (c) **Senior Citizen's Christmas Lunch –** Not many names had come to the fore by the meeting. Councillors would present names to the Clerk in due course.

11. County Councillor's Report – Cllr Clive Davies (*sent ahead of the meeting*):

- (a) **Improvements to the Mwnt Road –** He noted that he had spoken to Dyfed Symmonds and officers and the work should be completed before the end of the calendar year.
- (b) **Mwnt Lifesavers –** he attended a meeting with RNLI and had a discussion with the local authority and the National Trust. He asked for a much needed review of the beach which hadn't been conducted for over 10 years by the RNLI. Ceredigion completes a soft touch review on an annual basis.
- (c) **Mwnt Signs –** A picture of the signs as sent before were shown in time for the new season. New signs have been commissioned.
- (d) **Mwnt Defibrillator –** The National Trust will provide and install power. Community will need to fund raise and provide the unit. Sheila, the Trust Warden and Jenny have all said that they will contribute. Sheila will inform us as to the total raised so far. Cllr. Davies asked if the Community Council could also do so.
- (e) **Penyparc Reservoir –** Problems have existed with the area leaders since August. One leak had been repaired in September. The second leak will be repaired on 31 October. There is no leak in the reservoir itself.
- (f) **Plastic-free Cardigan –** It is hoped that a litter picking session will be arranged in Patch – we will be kept posted regarding who's taking part

- (g) **Dog mess signs** – He noted that he had talked to Rachel from Ceredigion County Council who stated that a small budget was available to create signs for the village, using school posters again if possible. The Clerk will contact Rachel regarding this.
