It was proposed by Cllr. Dilwyn Jenkins and seconded by Cllr. Melanie Davies that the minutes of the September meeting be recorded as correct.
- Declaration of personal interests:** Cllrs. Eurig Lloyd & Peter Williams declared an interest in correspondence 30 – a request for financial support from the PTA of Penparc Junior School
- Matters arising:**
 - Mwnt Di Fib** – a letter has been sent to the National Trust but, as yet no reply has been received.
 - 'Children playing' sign in Penparc** – Cllr. Clive Davies has enquired about a sign to be placed on the main road warning traffic about the playground, an assessment needs to be done and as yet he has not had a reply.
 - Notice boards** – Dyfed Symmons will replace the backing boards on some of the council notice boards in due course.
 - Hedge cutting at Cae Gwyrdd** – Quotes have been asked for from Mark Toft and Teifi landscaping but as yet not been received.
 - Dog fouling Signs** – Cllr. Eurig Lloyd had previously distributed old signs, and after discussion it was decided to ask the head teacher Mr Trystan Phillips of Ysgol Gynradd Penparc, whether a group of pupils would like to design new signs to be used in the village of Penparc for the winter months. 10. Other Matters:

- (a) **Meeting with the local police** – Cllr. Clive Davies (local member of County council) is meeting the local police in December and looking for volunteers to join the Zoom meeting – Cllr. Lloyd Jenkins and Cllr Matthew Morgan will join the meeting on 10/12/20 @ 6.30 pm to discuss local police issues.
- (b) **Dog fouling signs** – discussed in matters arising.
- (c) **Affordable housing** – After discussion regarding the number of complaints received by councillors regarding the possible sale of a house in Ferwig which was recently built as an affordable house but which has now been lifted (hearsay), it was proposed to send a letter to Mr Russell Hughes-Pickering Corporate Lead Officer: Economy and Regeneration for clarification if the clause had been lifted; when, and the

policy regarding affordable housing in the area.

- (d) **Damaged Sty in Penparc** – Clarification needed on who is responsible for a sty on the public footpath near to Penparc as it is damaged and poses a health and safety risk. Cllr Clive Davies will enquire.
- (e) **Playground closure**– there will be no need to close the play areas in Penparc and Ferwig during the current lockdown as they are allowed to remain open.

11. County Councillor's Report – Cllr Clive Davies:

- (a) **County council meetings** – these will continue through Zoom until at least April 2021.
- (b) **New staffing – Enforcement officers** – ensuring that new COVID 19 regulations are followed the next 6 months are crucial in the area.
- (c) **FastFibre** – Openreach are conducting a survey to map out which parts of Ceredigion have poor internet coverage and it is important for residents to highlight their concerns.
- (d) **Cae Gwyrdd signage** – the County council have 21 working days to response to the enquiry regarding signage at the play area in Penparc
- (e) **Lockdown** – there will be some monetary help for small businesses; recycling centres will be closed and events will be cancelled. Remembrance Sunday will be allowed to take place as a small event on 8/11/20
- (f) **Rubbish Collection in Penparc** – the County Council are aware there are issues but due to staff illness and redeployment the problem will be ongoing for a while Cllr. Clive Davies will chase up again.
