**1. Chairperson's welcome:** The Chair, Cllr. Auriol Williams, welcomed everyone to the March meeting. She sympathised with the family of Callum Lawrence of Heol y Felin who recently died.

**2. Apologies for absence:** Councillors Llinos Price, Dilwyn Jenkins, Lloyd Jenkins, Lyn Jones and Eurig Lloyd.

### **3. Minutes of the previous meeting**

It was proposed by Cllr. Matthew Morgan and seconded by Cllr. Des Davies that the minutes of the February meeting be recorded as correct.

**4. Declaration of personal interests:** Cllr. Matthew Morgan, please see Planning A200142.

### **5. Matters arising:**

- (a) **Annual Dinner:** A date for the Councillors annual dinner was discussed. A Friday night dinner was proposed if a Sunday afternoon is difficult to arrange. The Clerk will send an email to Councillors to ask for possibilities.
- (b) **Ferwig Telephone Kiosk:** The kiosk without a front door and operational telephone was discussed. Cllr Auriol Williams intended to look at it but it was agreed that the kiosk looks untidy and it would be good to dispose of it. Cllr Clive Davies informed that a process exists for this purpose and he would contact BT to enquire. The land on which it stands is County Council property.
- (c) **Hen Ysgol Plaque:** the stone is nearly ready to be reinstalled. A galvanised frame is now there. It was agreed that a letter would be sent to Mr Bell to inform him of the imminent work.
- (d) **Viewpoint:** Councillors were informed that the viewpoint car park needs to be resurfaced. Tarmac was proposed as it would be more hard-wearing. Cllr. Clive Davies will ask who is responsible for paying for this.
- (e) **Fence at Patch:** It was proposed to do something more long term, such as a car park, in order to prevent cars from parking there. Fence has now been repaired.
- (f) **Electricity Certificate:** need to know whether a certificate has been issued for Ystafell Berkley. To be discussed at the next meeting.
