10. Other Matters:

- (a) **Public footpaths** – concern expressed that they have been closed and now over grown. Cllr Dilwyn Jenkins has been in contact with Nigel Nicholas from CCC and that they will be cut in due course. Cllr Clive Davies confirmed that they are due to reopen on 17/7/20
- (b) **Lifesaving rings at Gwbert** – concern expressed that there is one missing from its location in Gwbert. Clerk has been in contact with Sam Trevor manager of Life guards who has passed the concern on to Cliff Bates.
- (c) **Hedge cutting** – they are currently being cut but the process is delayed this year and areas of Gwbert have yet to be cut.
- (d) **Cyclists** – a large number of bikes and groups of riders on the road. The public highway is open to all.
- (e) **Ceredigion's Response to COVID 19** - Cllr Llinos Price congratulated CCC and the people of Ceredigion for playing their part in keeping the county safe during COVID 19.

11. County Councillor's Report – Cllr Clive Davies:

- (a) **Response to COVID 19** – Track and Trace is in place with CCC and the roads in Cardigan will be closed to allow for more social distancing especially when people are queuing for key services such as the banks and post office. There will be free car parking in all car parks in Cardigan.
