## 15. Other Matters.

- (a) **Quotes for hedgecutting in Penparc** – The clerk is yet to receive any quotes for the work, Teifi Trees was put forward as another possible contractor for the work (the clerk will contact them as well).
- (b) **Entrance way to Penparc Chapel** – Some concern has been expressed regarding the size of plant pots near the entrance way to Penparc Chapel. Cllr Peter Williams volunteered to look at the problem and report back to the council in the next meeting.
- (c) **Waste collection at Penparc** – this is still causing an issue with bags being left out over night on Friday and the wind and animals then getting hold of the bags and causing a lot of rubbish, Cllr Clive Davies has agreed to ask again in Ceredigion if the problem could be resolved.
- (d) **Public Footbath/cycle path from Penparc to Cardigan** – This work needs to be completed but at present the work has come to a halt. Cllr Clive Davies will enquire with Cardigan council on progress and stress the importance of Ferwig Council being informed as the path joins Penparc which is in our council.
- (e) **Old age pensioners christmas lunch** – Due to Covid restrictions this will unfortunately not be able to take place this year. It was suggested by Cllr Melanie Davies that the council could give a hamper to residents who have attended the lunch during the last few years. This was agreed, and the Clerk will obtain prices of Hampers from Queens bakery and let the councillors know. Logistics regarding who will receive and their distribution will be discussed in the next council meeting.
