- 1. Chairperson's welcome.** The Chairperson, Cllr Lloyd Jenkins, welcomed everyone to the November meeting and extended his good wishes to Cllr Des Davies on hearing that he was unwell and currently receiving treatment. All the councillors expressed their good wishes to Cllr Des Davies and are looking forward to him returning to council meetings in a few months time.
- 2. Apologies for absence:** Cllrs Des Davies & Peter Williams
- 3. Minutes of the previous meeting.**
It was proposed by Cllr Auriol Williams and seconded by Cllr Eurig LLoyd that the minutes of the October meeting be recorded as correct.
- 4. Declaration of personal interests:** None
- 5. Matters arising:**
 - (1) Signage for Pengarn Pile – Information has been received regarding the sign, cost and position. It was agreed that the sign be ordered and placed at Pengarn.
 - (2) The Queen's Platinum Jubilee Beacons – information has been received regarding the beacons, and it was decided to discuss the possibility of purchasing one in the March meeting.
 - (3) Bus Shelters – Mark from Ultra Clean has agreed to clean all the bus shelters on behalf of the Community Council. Rob Wells has been in contact from the County council regarding the cleaning of the path and lighting needed at the bus shelter opposite OC Davies garage.
 - (4) Adopt a footpath – this has been successfully run in llechryd Council by Steve Kings, it was agreed that the clerk contact Steve to obtain more information regarding organisation etc in the community.
 - (5) Footpath from Cardigan to Penparc – Cllr Clive Davies confirmed that the plan was going ahead and that the landowners etc had agreed to the path.
 - (6) Tree cutting at Gwbert road- Cllr Adams-Lewis has been in contact to confirm that the County council had been in contact with the owners of the trees to have them cut back. This will be done, but unfortunately there are now road traffic lights at the junction, and therefore this work will have to wait until the traffic lights have gone.

10. Other Matters:

- (a) Coastal path signage at Gwbert – No longer relevant and does not need to be reinstated.
- (b) Senior citizens Christmas dinner – It was felt that a number would not attend due to the high risk of COVID in the area and that the hampers would be a better option again this year. Clerk to organise by December's meeting.
- (c) A request to the football pitch in Penparc – Aberporth football club is currently without a pitch due to the MOD reorganising itself. The football club would like to use the pitch and changing rooms for the winter months. It was agreed they could use the facilities for a fee of £25 a session and that the pitch and changing rooms were looked after. Clerk to organise with the YFC for cleaning etc.
- (d) Water on the road between Pille and Pengarn – clerk to notify Ceredigion County Council
- (e) Gwbert Viewpoint – clerk to send an email to Mr Arwyn Davies to confirm a timeline of when the work on the surface of the car park will be completed.
- (f) Fireworks – we need to find out the rules regarding the lighting of fireworks near live animals.

11. County Councillor's Report – Cllr Clive Davies:

Several points were already covered in the meeting – but in addition

- (a) Phosphate levels are causing issues in planning consent along the river Teifi.
- (b) Problems with second homes in Ceredigion is increasing and Cllr Davies is currently writing a report on the affect of this on the area.
- (c) The investigation into the suitability of Penparc for people with sight problems was completed and discovered that tactile paving works well in most of the village with only 2 areas causing concern that would need to be revised to make them suitable for all visually impaired residents.
- (d) The need to organise a Speed Watch group in Penparc still stands. We currently need more volunteers.
