**5. Materion yn codi / Matters arising:**

- 1) Gwasanaeth Bws yn Ferwig/ Service Bus in Ferwig. Ar ôl cyslltu gyda'r cwmni bws lleol ac hefyd yr adran trafniadaeth Ceredigion mae'n amlwg bod y cwmni bws wedi penderfynu peidio a adnewyddu ei tender. Mae'r Cardi Bach dal yn rhedeg ac hefyd gall trigolion defnyddio Bwcybus. Angen i'r clerc cael amseri y Cardi Bach i hysbysebu yn y llochesu bws.**

After contacting the local bus company and the transport department of Ceredigion it has become apparent that the bus company has withdrawn their tender. The Cardi Bach continues to run, and residents can use Bwcabus. Clerk to find details to advertise in the bus shelters.

- (2) Llwybyr Cyhoeddus ger Gwesty'r Cliff/ Public Rights of way near the Cliff Hotel. Cafwyd cyfarfod llwyddiannus iawn gan Osian Jones Swyddog Llwybrau o Geredigion, Mr Wells Jones perchennog Gwesty'r Cliff ac hefyd 3 aelod or Cyngor Cymuned. Mae yna 3 pwynt – angen arwyddion tuag at y llwybr i'r chwith o'r Gwesty (Osian Jones i'w drefnu). Angen glanhau grisiau i fynd lawr i'r traeth bach eto i'r chwith o'r Gwesty (Osian a Wells i'w trefnu rhyngddynt). Angen rhoi iet fach wrth gwaelod y ffens sydd yn mynd o flaen y Gwesty. (Osian i'w drefnu ai rhoi yn i le.) Mae yna waith i glanhau a paentio 3 sedd sydd ar y llwybr, ac mae Wells Jones wedi cynnig staff y gwesty i wneud hyn. Teimlau pawb bod angen Hysbysfwrdd Gwybodaeth sydd ac enwau y traethau ayyb arno. Cytunwyd y Cyngorwyr i edrych mewn i pris am fwrdd ai leoli ger y safle parcio. Y Clerc i ddechrau gwneud ymholiadau am cynllunio bwrdd.**

A very successful meeting was held between Osian Jones, Footpath Official, Mr Wells Jones Cliff Hotel owner, and several councillors on the public rights away around the Cliff Hotel. Three main points arose; Signage is required for the footpath to the left of the Hotel to guide people in the car park (Osian Jones to organise), the steps leading down to the small beach on the left of the hotel needs to be cleaned (this to be organised between Osian and Wells), a small gate is needed towards the end of the fenced footpath near the grounds to the Hotel. (Osian to organise). It was felt that an information board would be a very useful addition at the start of the public rights of way. Councillors agreed to this in principle and the clerk to start looking into some designs and costs.

**1. Cwrs Di Fib yn Ferwig ar nos Lun 28 Fawrth yn llawn. Grantiau ar gael am fwy, a oes angen rhai yn rhywle?**

The Defib course organised for Ferwig on 28 March is fully subscribed. There are further grants available and does anyone know of anywhere in the area that would like one?

**2. NRW dal yn achosi oedi yn ceisiadau cynllunio ym Mhenparc – mae hyn yn achosi pryder.**

NRW regulations continue to cause delays in planning applications for Penparc – this is causing a lot of backlogs in the system.

**3. Cyfarfod PACT nos Fercher 16/3/22, a oes unrhywbeth gan rhwyun i godi?**

PACT meeting on Wednesday 16/3/22 – anything to discuss?

**4. Grwp Gwyllo Cyflymder ym Mhenparc wedi dechrau ac yn effeithiol iawn wrth i'r grwp cael i hyforddi i ddefnddio yr offer gan heddlu lleol.**

The first outing of the speedwatch group was very successful after receiving training from local Police officers in the correct use of the equipment.

**5. Nifer o neuaddau cymunedau eraill nawr yn holi am grantiau i ail wneud yr adeilad ar ôl gweld y gwaith da yn Ferwig.**

Several local communities are looking into grants that are available into upgrading village halls etc after the successful completion of Ferwig.

**6. Fel ymddiriedolwr o'r CAB i ni wedi gweld nifer fwy o teuluoedd mewn tldi – a gorfod gwneud y dewis rhwng 'bwyd neu gwres' – fydd hyn siwr o fod o bryder i nifer yn y dyfodol. Fyddau yn syniad i rhoi rhif CAB lan yn yr hysbysfyrdau.**

As Trustee of the local CAB group, it is worrying to see so many families in poverty – and having to make the choice between 'food or heating', and unfortunately this may be a choice many will have to make in the future. It may be an idea to place the CAB help line number in the noticeboards.

**7. Unwaith eto mae Ceredigion heb hawlio trwydded ar gyfer Casino yn Ceredigion. Once again, a gambling licence for a casino has not been granted by Ceredigion.**

**8. Fydd Treth y Cyngor yn codi 2.5% blwyddyn nesaf, ac nid y 4.2% a oedd yn cael ei awgrymu. Ceredigion Council Tax will rise by 2.5% rather than the 4.2% that was originally expected.**
