Codwyd gan y Clerc bod SWALEC wedi rhoi y Cyngor ar tariff busnes amrywiol ers tipyn, ac bod hi yn methu cael pris sefydlog ar hyn o bryd gan bod cwmnioedd yn teimlo bod y farchnad mor ansefydlog. Mae yna grwpiau priodol yn medru holi am prisau i Gynghorau, ac mae'r Clerc wedi siarad ag un er mwyn trio cael pris. Mae hefyd angen siarad gyda'r trydanwr, Barri Davies i cael paneli solar i roi ar yr ystafelloedd newid. Clerc i siarad gyda Barri eto. Wnaeth Y Cyng. Clive Davies sôn bod yna grantiau newydd Eco Flex yn dod allan yn yr Hydref a gall y Cyngor gwneud defnydd o rhain.

The clerk raised the issue of SWALEC placing the Council on a Variable Business rate tariff for the electricity which is considerably higher than previously. Although the clerk has tried to get a contract, SWALEC have not given a price as the market is so unstable. There are buying groups for charities that can try to find energy prices and the clerk has been in contact with one of these. It was discussed again to chase up the electrician Barri Davies about getting solar panels installed on the roof of the changing rooms – clerk to
