Peter Williams bod cofnodion mis Ionawr yn gywir.** *It was proposed by Cllr. Melanie Davies and seconded by Cllr. Peter Williams that the minutes for the January meeting be recorded as correct.*

- 5. Materion yn codi / Matters arising:**
  - (1) Arwydd Pengarn Pille /Signage at Pengarn Pille – siomedig iawn bod yr arwydd wedi cael l'w osod tua 10m o'r lle a gofynwyd.** **Cyngor Sir yn methu dilyn cyfarwyddiadau. Cynigwyd gan y Cyng. Lyn Jones bod y Cyngor Cymuned ddim yn talu am y gwaith gan ei fod wedi cael l'w lleoli yn y lle anghywyr. Cytunwyd yn unfrydol a hyn.** *The council is very disappointed with the response from the County Council that the signage has been placed some 1 m from the site that was identified – CCC have admitted that it is in the wrong place but are not going to move it. It was proposed by Cllr Lyn Jones that the Community Council do not pay for the work that has been carried out if a bill arrives. This was unanimously agreed.*
  - (2) Cynllunio ger Madiwela/ Planning near Madiwela – Cafwyd trafodaeth eang am y cynllunio yma ac mae'r Cyngor yn siomedig iawn gyda maint yr adeiladau. Aros am ymateb.** *A detailed discussion was held on the development after many councillors had received complaints from residents. It was felt that as so many changes had been made to the original plans from some 10 years ago that is it was difficult to keep up with the size and proportion of the buildings. Cllr. Clive Davies has enquired if the current buildings are following the planning consent given. He is awaiting a reply.*

## 10. Materion Eraill / Other Matters:

- (a) **Arwyddion Twristiaeth Gwberr/Gwberr Tourism Boards – Mapiau ac ati wedi dod ar glawr gyda'r enwau cywir. Clerc ar Cyng. Eurig Lloyd i ddechrau cynllunio.** Maps of the beaches etc have been found which can be used for the information board. Clerk and Cllr Eurig Lloyd to meet and start to design.
- (b) **Cerbyd yn Penparc/ Parked car in Penparc – Mae'r heddlu ar cyngor wedi cael cwnion am y car – ar hyn o bryd mae yna rhybudd arno iddo cael i symud o fewn 7 diwrnod.** Several complaints have been received and it has been reported to the police and Ceredigion County Council. The council has placed a warning notice on the car asking for it to be moved within 7 days.
- (c) **Draeniau wedi'u blocio/ Blocked Drains – Cwynion bod yna draeniau wedi eu blocio ar heol Hafod – Clerc wedi rhoi gwybod i'r Cyngor.** Complaints regarding blocked drains on the Hafod road – clerk has informed the Council.
- (d) **Camber Heol Tywod – Y Cyng. Peter Williams wedi cwyno ir Cyngor Sir am y sefyllfa a bod yna**

draen wedi suddo. Cyngor wedi bod allan a dechrau trwsio. Hyn ar ôl nifer oalwadau i CCC i sortio trwy Cyngor Cymuned y Ferwig ac yn union gyrchol ers mis Mai 2022. Cllr. Peter Williams highlighted the sunken drain at Heol tywod – which he initially reported via Ferwig Community Council in May 2022 and more recently directly to CCC, they have now been out to assess the work which has since started.

- (e) **Llwybr cerdded Caemorgan/** Public footpath Caemorgan – **Y Cyng Peter Williams wedi holi am cynnydd yn y llwybr – mae pob dim yn mynd yn i flaen ond fydd yna sawl blwyddyn eto cyn fydd yna lwybr.** Cllr. Peter Williams has requested a progress report – it is moving forward but it is estimated that it will take another 3 years for the footpath to be completed.
- (f) **Meinciau Mwnt/** Benches at Mwnt – **Cafwyd trafodaeth am y nifer o meinciau sydd angen ac hefyd y posibilrwydd o meinciau smart, ble fedrwch cynhyrchu trydan trwy solar i fedru pobl gwefru eu ffoniau symudol.** Discussion on benches with the possibility of one of them being a smart bench which will allow people to charge phones etc on them.
- (g) **Levelling up/ codwyd gan y Cyng. Dilwyn Jenkins bod yna cwyn gan Ben Lake AS bod yna arian dros ben ac efallau fyddau ar gael i gwneud gwelliannau yn Gwbert. Angen i'r clerch danfon llythyr i'r ysgrifennydd David Davies i weld a oes mwy ar gael. Hefyd angen holi y Cyng. Clive Davies i weld a oedi CSC wedi rhoi cais mewn am yr arian.** It was raised by Cllr. Dilwyn Jenkins that Ben Lake MP had raised issues with the levelling up of money that remained. Could this money be used in Gwbert? Clerk to send a letter to Welsh Secretary David Davies to ask if more money is available, and to check with Cllr Clive Davies that Ceredigion has asked for a portion of the money that is now available.
