- (a) **Bin ger Gwesty'r Cliff/Bin near the Cliff Hotel. Yn y mis diwethaf mae Mr Wells Jones, (Perchennog y Gwesty) wedi rhoi bin sbwriel ger y llwybr ar bwys rhai o'r traethau sydd ar y llwybr. Mae hyn oherwydd faint o sbwriel sydd i'w gweld ar hyd y lle. Cytunwyd y Cyngorwyr a hyn ond maent yn annog iddo cael i gwagu yn aml iawn gan bod rhai o trigolion Gwbert wedi bod yn cwyno eu bod yn orlawn ar brydiau.** In recent months Mr Wells Jones, (owner of the Hotel) has placed a bin near to the footpath down by some of the small beaches, because there has been an increasing amount of rubbish being littered along the coastline. The Councillors are happy with this in principle but feel it must be emptied regularly as residents complain when the
