12. Adroddiad y Cyngorydd Sir, y Cyng. Gethin Davies *County Councillor's Report*

Mae Y Cyng Gethin Davies wedi bod yn brysur gyda nifer o ceisiadau cynllunio yn yr ardal, gan cynnwys un ble roedd yn cwrdd a Ben Lake AS a Elin Jones AS i drafod y mater. Wnaeth hefyd esbonio bod Ysgol Gynradd Aberporth heb cael unrhyw fusoddiad ariannol ychwanegol ers nifer o flynyddoedd, ond maent wedi bod yn llwyddiannus yn ddiweddar wrth cael fuddosiad o £1m i'r ysgol. Mae Aberporth yn dechrau mynd yn tipyn yn fwy prysur wrth i wyliau yr haf ddechrau mewn rhai wythnosau. Cllr. Gethin Davies has been involved in several site meetings including a meeting with Ben Lake MP and Elin Jones AS regarding planning applications in the area. He also highlighted that Ysgol Gynradd Aberporth had not received any additional funding for several years, but that they had recently been successful in securing £1m of additional funding for the school. Aberporth is also gearing its self-up for a busy few weeks with school holidays approaching.
