12. Adroddiad y Cynghorydd Sir, y Cyng. Gethin Davies County Councillor's Report

Mae yna lai o ymwelwyr wedi bod yn Aberporth yr haf yma gan bod y tywydd wedi bod yn anafriol iawn ar brydiau. Mae yna tipyn o waith wedi mynd yn ei flaen yn cadw y pentref yn daclus ac hefyd wedi bod yn gwneud peth gwaith ar llwybr cerdded Dick yr Hendre – mae hwn yn llwybr poblogaidd gyda nifer yn cerdded arno. Aberporth has not been as busy this year – possibly due to the adverse weather that we have had at times. A lot of work has been done in keeping Aberporth tidy and litter free, as well as some of the public paths – especially the Dick Yr Hendre Path has had some work done on it as this is a popular walk.
