- Croeso'r Cadeirydd / *Chairperson's welcome*:** Croesawodd y Cadeirydd, y Cyng. Melanie Davies, pawb i'r cyfarfod.
The chairperson Cllr. Melanie Davies welcomed everyone to the meeting.
- Ymddiheuriadau am absenoldeb / *Apologies for absence*:** Y Cyng. Mair Bell a Y Cyng. Eurig Lloyd
- Cyfarfod Cyhoeddus yn ymwneud a cais cynllunio A240043 / *Public meeting regarding planning application A240043***
Croesawodd Y Cyng. Melanie Davies bawb i'r cyfarfod cyhoeddus i drafod Cais cynllunio A240043. Roedd 20 o drigolion ward Ferwig yn bresennol. Agorodd y Cyng Melanie Davies y cyfarfod trwy ddarllen y llythyr a dderbyniwyd oddi wrth Mr Daniel James, Stepside Agri yn egluro na fyddai'n mynychu'r cyfarfod ond eglurodd rai pwyntiau yn ymwneud â'r leinin, gorchudd a phryderon trafniadaeth. Roedd y llythyr hefyd yn tynnu sylw at y ffaith ei fod eto'n croesawu unrhyw drigolion i wneud apwyntiad i gwrdd ag ef a thrafod unrhyw bryderon oedd ganddynt.
Mynegodd y trigolion eu siom nad oedd Mr James yn mynychu'r cyfarfod, fodd bynnag, cafwyd adborth gan Brenda Howells a oedd wedi derbyn y cynnig i gwrdd â Mr James i ateb cwestiynau. Dywedodd fod y cyfarfod yn addysgiadol a buddiol, gan ateb llawer o bryderon a godwyd ganddi. Yna roedd cyfle i drigolion fynegi eu pryderon a gofyn cwestiynau. Nid oedd y Cynghorwyr yn gallu ateb y cwestiynau, ond roeddent yn deall y prif faterion gyda'r cais. O'r drafodaeth, y prif feysydd pryder oedd:-
 - Roedd preswylwyr yn siomedig nad oedd Mr James wedi mynychu'r cyfarfod i egluro meysydd a chaniatáu i'w pryderon gael eu mynegi. Teimlent y byddai hyn wedi helpu'r broses ymgeisio drwy roi eglurder.
 - Trafniadaeth, maint a nifer y tanceri yn ogystal â'r gyffordd gyda'r A487 a thraffig Tremain.
 - Y lagŵn – ei leinin/gorchudd a'i leoliad.
 - Cynnwys y lagŵn – arogl a sut a phryd y byddai'r sgil-gynnyrch yn cael ei roi ar y tir.
 - Goblygiadau iechyd i drigolion cyfagos a'r Ysgol sydd wedi ei lleoli ymhellach i fyny'r allt.
 - Nant Arberth; bywyd gwyllt lleol a diffyg adroddiad ecoleg manwl ar y cais.Roedd y trigolion wedi paratoi cwestiynau ar gyfer y cyfarfod a chynigiwyd bod y Clerc yn llunio rhestr o'r cwestiynau a fyddai'n cael eu hanfon at Mr James i'w hateb. Yna gellid dosbarthu'r cwestiynau hyn a'r atebion gyda'r trigolion.

The chairperson Cllr. Melanie Davies welcomed everyone to the public meeting to discuss planning Application A240043. There were 20 residents from the Ferwig ward in attendance. Cllr Melanie Davies opened the meeting by reading the letter received from Mr Daniel James, Stepside Agri explaining that he would not be attending the meeting but clarified some points relating to the liner, cover and transport concerns. The letter also highlighted that he again welcomed any residents to make an appointment to meet with him and discuss any concerns they had.

Residents expressed their disappointment that Mr James was not attending the meeting, however, feedback was given by Brenda Howells who had taken up the offer to meet with Mr James to answer

queries. She said the meeting was informative and beneficial, answering many concerns she had raised. There was then an opportunity for residents to express their concerns and ask questions. Councillors were unable to answer the questions but could understand the main issues with the application. From the discussion the main areas for concern were: -

1. Residents were disappointed that Mr James had not attended a meeting with residents to clarify areas and allow their concerns to be expressed. They felt that this would have helped the application process by giving clarity.
2. Transportation, the size, and number of tankers, as well as the junction with the A487 and traffic in Tremain.
3. The lagoon – its lining/cover and location.
4. The contents of the lagoon – odour/smells and how & when the by product would be applied to the land.
5. Health implications to nearby residents and the school which is located further up the hill.
6. Nant Arberth; local wildlife and the lack of a detailed ecology report regarding the application. Residents had questions prepared for the meeting and it was proposed that the Clerk compile a list of the questions which would be sent onto Mr James for him to reply to. These questions and the replies could then be distributed with the residents.
