- 1. Croeso'r Cadeirydd / Chairperson's welcome:** Croesawodd y Cadeirydd, y Cyng. Melanie Davies, pawb i gyfarfod mis Chwefror gan cynnwys rhyw 15 o aelodau'r gymuned a oedd am trafod cais cynllunio A230043 yn Trefwtial. Cytunodd y Cadeirydd i drafod y mater yn gyntaf. Wnaeth sawl preswylwr codi pryderon ac ofyn am atebion i nifer o gwestiynnau yn ymwneud â y math o ddefnydd bydd yn cael eu storio yn y lagŵn, faint o lorïau bydd ar y ffyrdd, ac hefyd cwestiynnau amgylcheddol, a'r ffaith fod yna adeilad rhestredig Gradd II ar y ffyrdd tuag at y lagŵn. Roedd rhai trigolion yn anhapus gan eu bod heb derbyn llythyr am y cais wrth Cyngor Sir Ceredigion a bod y rhif ffon ar yr hysbysiad safle yn anghywir. Cynygwyd cael cyfarfod cyhoeddus am y cais er mwyn i bawb cael y cyfle i mynegu barn. Cytunwyd ar y pwyntiau gweithredu canlynol:
 - a) Angen cynnal cyfarfod cyhoeddus yn fuan yn Ystafell Berkely, ac angen estyn gwahoddiad i'r ymgeisydd i rhoi gwybodaeth am y cais yn y cyfarfod. Bydd hefyd angen i preswylwyr cael llefarydd a rhestr o gwestiynnau yn barod. Bydd y clerc yn ebostio pawb gyda dyddiad y cyfarfod.**
 - b) Y clerc i edrych ar y rhifau ffon ac ati a rhoi gwybod i'r Cyngor Sir os bod y gwybodaeth yn anghywir.**
 - c) Y Clerc i dosbarthu rhif ffon ac ebost y Cyngor Sir i drigolion trwy ebost.**

The Chairperson, Cllr. Melanie Davies, welcomed everyone to the meeting which was attended by some 15 members of the community who wished to discuss planning application A230043 at Trefwtial. The Chairperson agreed to discuss the application at the start of the meeting. Several residents voiced their concerns and had questions that needed clarification such as; the waste material the lagoon would hold, the number of lorries on the road, and questions surrounding environmental concerns, including the presence of a Grade II listed building located on the road towards the lagoon. Some residents were also unhappy that they had not received notice of the planning application and that the telephone number on the public notice was not in use. It was proposed to hold a public meeting to allow concerns to be addressed. The following action points were agreed:

- a) To hold a public meeting as soon as possible in Ystafell Berkely, and invite the applicant to present information at the meeting. There would also be a requirement that residents have a spoke person and list of questions to be addressed ahead of the meeting. The clerk will email everyone concerned with the agreed date of the proposed meeting.*
- b) The clerk to check telephone numbers etc and notify Ceredigion County Council that some residents have not received the required notification.*
- c) Clerk to share the telephone number and email address for Ceredigion Planning to all concerned residents.*
