- a) **Blwch blodau i addurno pentrefi/Flower boxes placed to decorate villages.** Mae Mr Gareth Lewis wedi gwneud 7 blwch, ac fe'u gosodwyd yn eu lle gan Gareth, Mr John Morris a'r clerc yr wythnos diwethaf. Mae sawl person wedi gwneud sylwadau amdanynt ac maent yn edrych ymlaen at eu llenwi â blodau yn fuan. Yn anffodus, mae Mr Rob Wells o'r asiantaeth gefnffyrdd wedi bod mewn cysylltiad - mae'n bosibl iawn bod rhai o'r blychau wedi'u gosod yn rhy agos at y ffordd - mae wedi addo ymchwilio i'r mater a chynghori ar rai lleoliadau mwy addas. **Bydd y Cyngor yn aros am ei gyfarwyddyd!** *Mr Gareth Lewis has made 7 boxes, and they were put in their place by Gareth, Mr John Morris and the clerk last week. Several people have commented on them and are looking forward to them being filled with flowers soon. Unfortunately, Mr Rob Wells of the trunk road agency has been in contact – some of the boxes may well have been placed too near the road – he has promised to investigate the matter and advise on some more suitable locations. The Council will await his instruction!*
